## Table & Price Information:

- 8' Tables are available for \$425 Front, \$325 Middle, and \$225 Back per table. Bourse space consists of table, back table, and electrical outlet. Paid in full guarantees your spot.
- Cases are Available to rent for \$25 each, and Lights for \$15 each.
- Two Dealers may share a table so long as prior consent is given by Mike Boyer. Tables may not be given to another dealer and/or resold.
- You must put a \$50 deposit to reserve your table, but to ensure your tables are locked in, please send Check for the ENTIRE AMOUNT DUE BY APRIL 1<sup>st</sup>, 2027.
- Early Bird Badges will be available for \$75 each for 2pm-5pm on Wednesday, or \$100 at noon with the dealers, and will be good for early admission on all 3 show days.

## Dealer Setup & Information:

- Dealer Setup is on Wednesday from Noon - 5pm, and Thursday Between 8am and 10am.
- Applicants will be required to conduct themselves in a manner befitting the dignity of the local, state, and national numismatic organizations.
- You agree to furnish your own insurance as it will not be provided by the show, the shows organizers, or the venue.
- Armed Security will be provided for 24 Hours a day for the length of the show.
- By filling out the dealer application, each applicant agrees to hold harmless Mike Boyer, Mid America Coins, and the Ruffin Event Center or its owners for any losses occurring during or after show hours.
- Smoking is strictly prohibited inside the venue.
- Counterfeit Merchandise may not be offered for sale unless CLEARLY marked as such.

## Cancellations:

- You may cancel your reservation and table so long as it's at least 30 days before the show. Cancellations after May 11<sup>th</sup>, 2027 will not be refunded.
